



I don't use or even know how to use rec center

Alta rec center needs to be either fully tax payer funded, or completely self sustaining. We shouldn't be spending tax payer dollars for a facility that competes with the local economy and still charges us to use it. It also duplicates efforts already being done by the county. This essentially means that Sandy City residents are being charged for rec centers by two government entities, but of they want to use them then they need to pay an ADDITIONAL fee beyond their annual property tax subscription fee. I am opposed to any dollars going toward it.

Most families who are normally financially comfortable are barely getting by right now with inflation and gas prices. It's not the right time to talk about any increases.

Alta Canyon really deserves a major upgrade.

I would pay to renovate Alta Canyon if I was in the service area for resident rates when paying for a membership. We are in Sandy but have to pay non-resident rates when we go there.

Creative solutions should be sought for the expensive rec center upgrades- fundraisers, increased dues (while finding ways for lower income residents to still use the amenities), or other funds that don't involve huge property tax increases.

Alta Canyon can turn into a madhouse zoo over summer months. I don't know if expanding the size / capacity of the current facility makes sense without accounting for the increased traffic: more parking, a traffic light.

Although I live in Sandy I am not considered a "resident" for Alta Canyon so I would not contribute towards that unless that changed.

What about the west side of the city for a rec center?

I believe Alta Canyon should be part of the Salt Lake County network of Rec Centers in the valley.

I believe Utahns have been taxed way to much we need to focus on things like police and fire departments not public rec centers

Need more EV chargers at employers parking lots. Offer them discounts to install. Let's breathe cleaner air. Maybe more Park n Ride lots.

Quit raising taxes and use the existing funds for building needs.

An additional ice sheet is needed in the Salt Lake Valley. Hockey is becoming hugely popular and it is becoming very difficult to get ice time.

In historic sandy we have a number of empty plots. And our trax station has no ornamentation. The empty plots are either owned by the LDS church or by the City or by the City Redevelopment. All that each of these has to do is put the plot up for sale or listen to the community to do something with it. But they still remain vacant after 3 years.

Budget budget and done raise our taxes already paying so much

Alta Rec Center provides needed after school care for local residents. Its pool is packed all summer. Local residents need additional opportunities for summer activities during workdays. While all projects are needs, prioritizing this facility appears to benefit more residents directly.

People on a fixed income, old people like me, are disproportionally affected by property tax increases. Please don't make it so expensive to remain in our homes.

I do not feel we should grow Sandy any more. We do not have enough water, all of our roads are over crowded now, our sewer treatment is about at max. Our governments just seem to want to grow every thing, bigger is not better. We have paid to get where we are, why should we pay more for others who ar not even here?

I live in old Sandy. Here we go again spending more money on the East Side for a project no one where I live even uses, what else is new? A face lift for Main Street Park has been promised for 25 years and nothing gets done, but I guess if someone wants an indoor basketball court, the city open's its wallet. We have had promises and meetings at the old Sandy park over the years, it is still the same as when it was first built, well the rose bushes are gone. I guess you will just close and sell the old city hall to a developer for more apartments. Where is our community center? We need it. Look how much money was spend on the Senior Citizen Center. That used to be in old Sandy too, rather than improving the old area, it makes sense to

spend that somewhere else I guess. When that was moved, we got promised a community center, still nothing. I voted for you Mayor Zoltunski, please find a way to help us here. My council member does not even live around here.

There's so much space in and around Alta Canyon; it could really become a great facility for community activities and athletics, more like Dimple Dell and Cottonwood Heights. I really hope others agree to invest!

I do t see that Alta is a priority at 40-47M if this is a substantial piece of the budget. I'd like to see the current parks and Rec centers throughout Sandy being updated instead. I believe that Copperview could use a move or a large update for the kids in the lower income part of Sandy. I also believe that these programs could use more exposure in the neighborhoods and communities directly in their influence. Alta was always expensive and had many things that lower income families either aren't interested in or couldn't afford. Let's focus on the lowest in Sandy and build up from there!

Money for these projects should come primarily from reducing operating costs from the city budget. If businesses, including hospitals, can reduce costs without reducing quality, sandy can do. Adding more police officers has done nothing.

Taxes increase was too much.

While I know that Sandy City has had a minor impact on my overall property taxes, as a retired person I cannot afford anymore increases in my property taxes and still keep my home. But then I am sure politicians don't care. When I purchased my Sandy home in 1986 my property taxes were about \$600 per year. Now they are over \$3000 per year and have been increasing by as much as 15+% per year for the past 10 years. Some how, this has got to stop!!! My home was built in 1975 and I don't have the luxury to just say, oh lets build a new one and have someone else pay for it. But I guess if the payment is stretched out over 30 years, I will probably be dead before it is paid for and some political wizard decides to do this all over again. Let see, Alta Canyon center was built in 84' and has had some improvements along the way. Bonding an funding for it has had a checkered pass, when were told that Jordan School district would help with future improvements when they build the high school next

if you really desire input from the citizens....please educate us. links for these projects would be soooo simple to include on this vote. disappointed that you are willing to take input from people that you have no idea if they are informed or not about these very important issues.

I understand these projects are important, but considering the reassessments in property values well above the rate of inflation, Sandy City should have seen an increase in revenue above the increase in spending. Essentially, we are being taxed on the unrealized gains in our property value. As such, I would expect my city' budget to be run in such a manner where capex projects are planned, budgeted, and saved for in advance, this eliminating the need for tax increases to pay for special projects. Just like a household budget, we save up in advance for future anticipated expenses. I would expect government budgets to be managed similarly.

My concern with the Alta Canyon remodel is that the entire city has to pay for it, yet if you don't live above 1300 East you have to pay extra to use it. That doesn't seem fair. Unless it is open to everyone after the remodel. Doesn't Dimple Dell work? That is a lot of money that is being asked to pay for the remodel.

Would selling the land that the current Station 31 is on recoup some of the replacement cost and be used to make a big payment toward the bond after the new building

The city taxes me quite enough already. Love within current budgets.

Alta Canyon rec center should be voted on by the whole city to determine if it should be rebuilt torn down or remodeled. It shouldn't be up to seven elected officials to make a decision to spend 40+ million dollars on a rec center the 1/4 of the population uses an out of that quarter population it's closer to maybe 500. Actually use the facility. Tell the council no, let the citizens decide.

I live in Sandy, but in the wrong zip code to get a discount at Alta Canyon. My friends in the Alta Canyon zip code pay the same as me at Dimple Dell Rec Center and that's my zip code. Why would I have my taxes raised to pay for Alta Canyon rec center when I already pay more to use it as a Sandy resident based on my zip code. Ask the Sandy residents getting the zip code discount to add it to their taxes instead of mine.

Alta Canyon is so far East and is used by wealthy residents... Doesn't need to be funded by everyone.

Sandy has had substantial tax hikes over recent years, as has Salt Lake County, and the school district. I just paid my annual property taxes which were substantially more this year than the previous year, which was substantially more than the year before that.

I am not unwilling to cover costs for more recreation centers, not near Alta. we need to be focusing further west in sandy and create places for teens and tweens to affordably occupy their time.

Proposal: Tax free property for retirees!

Alta Canyon should NOT be responsibility of Sandy City. It should be fully funded by members, including Administrative costs incurred by Sandy City.

Focus on the basics of public safety and providing basic services and leave the rest up to private enterprise.

We don't take advantage of the Alta Canyon RecCenter because it does NOT take Silver Sneakers or Renew Active for seniors.

I do not use recreational facilities and would not want to pay more for that. I believe that a fire station is vital and I am willing to see that cost pushed out. If people want and use the recreational facilities, they should be the ones to pay the costs associated

AECOM's October 2021 Alta Canyon Feasibility Analysis commissioned by Sandy City Council showed Alta Canyon had 1827 members. U.S. Census Bureau for Sandy population in 2021 was 90,505. Based on those numbers Alta Canyon in 2021 was serving a mere 1.92% of Sandy's population. The past 12 months population increase will not dramatically increase the usage percentage. Supporters of Alta Canyon raised the fact they gain immeasurable health and emotional enhancement benefits from recreation facilities offered by Alta Canyon. Those same benefits also exist in privately and professionally run gym/recreation centers. The void in not having Alta Canyon will very quickly & easily be filled by the many private gym/recreation centers found throughout the city. I want my hard earned tax \$ go to Fire Station 31 and Public Works Building which are city needs. Alta Canyon is a 'want'. They city can easily survive without it.

City Council needs to listen more to what the citizens of Sandy want. I thhought they worked on our behalf.

I think that we can work on all three of these projects simultaneously.

Fire station only; relocate public works to private vacated buildings that are not being used or leased; NO ACSC! We have Dimple Dell and wonderful private businesses to support!

What are you thinking? People are having trouble buying food and gas. Some may be losing their homes. We are in a recession for crying out loud! Are all you people rich? There are a lot of young people and old people out their who don't need another burden. And believe me that once a tax is implemented, it does not go away. That rec center only serves a small percentage of our city's population and doesn't offer anything different from what the surrounding county rec centers offer. Please don't waste our money on this. If you insist on going thought with it, atleast put it on the ballot so that the residents of Sandy can definitively decide once and for all if they want to pay for it.

A premier rec center would be a showcase and a selling point that would increase property value and tax revenue

No more high rise apartments! They are nothing but a pain! The ones by us do not have sufficient parking so they park on the nearby roads. It is ridiculous. And they are still building. They should have to tear some down to make enough parking for their tenants. Why does the Planning Department not think of these things and plan for them. Parking on the road overnight is illegal from Nov. 1 to April 1. Our road has twenty plus vehicles parked on it. That is a big safety issue. And the no parking law is not enforced!!! There is way too much traffic on the road already. And many drive too fast. We do not have the resources for all these people in small areas. Where is the common sense?!?

Users of Alta Canyon have to pay a fee to access facilities. With added amenities after spending \$40-\$47 million for the rebuild the Alta Canyon fee will increase. There are other recreation gym centers that residents can pay for access which will not impose tax dollars on residents. Our pockets are already stretched due to high inflation, gas price increase and expansive job lay offs. We cannot afford more tax hike to pay for a "want". We will dig into our pockets for city safety needs but for now and next few years will not agree to more tax hike for a "want" that is used by a very tiny number of Sandy residents. In 2021 Alta Canyon members was 1827. Sandy population in 2021 was 90,050.
